In order to complete your membership application, you must read and sign the attached guidelines and wavier.

1. Membership entitles listed drivers to drive approved karts on the Bakers Creek Kart Club track during open non-race days for 1 membership year.
2. Allowing an unauthorized or unsupervised non-member access to the track may result in suspension of your access and membership privileges. A qualified track supervisor must be present at all times when anyone is using the track for qualified club use.
4. Each membership is entitled to one vote.
5. Duties of a duly accepted member are to know and uphold the rules of the Bakers Creek Kart Club.
6. Make sure track is secured when arriving and leaving.
7. Report any and all rules violations and or / safety or facility issues to the track steward or club officer.

**Membership does not include Medical or Liability Insurance Coverage. The official liability waiver must be signed, and a wristband purchased and worn at all times in the track and pit areas during practice or race event.**

**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION of being permitted to enter for any purpose, any restricted area (herein defined as including but not limited to, the racing surface, pit areas, infield, burnout area, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, **EACH OF THE UNDERSIGNED**, for himself or herself, his/her personal representatives, heirs and next of kin, acknowledges, agrees and represents that he/she has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted area or areas and his/her participation, if any, in the event constitutes an acknowledgment that he/she has inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purpose of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about restricted areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the restricted areas immediately.

**All applicants and assignees HEREBY RELEASE, WAIVE, DISCHARGE AND CONVEY NOT TO SUE** the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in injury or death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in any event at the assigned facility.

**All applicants and assignees HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

**All applicants and assignees HEREBY ASSUME FULL RESPONSIBILITY FOR, AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE** due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.

**EACH OF THE UNDERSIGNED** expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
